1 Top Import Countries in U.S.

As shown in Figure 1, Top 15 import countries in the U.S. are shown for the past September (2022.9). China is still the number one importer in U.S. market, reaching a monthly total number of more than 869K entries of imported records (lines). Behind China, Mexico and Canada take up the second and third place, respectively.

Note: According to U.S. CBP, "country of origin" refers to the country of manufacture, production, or growth of the article (product).

2 Major Import Manufacturers

Figure 2 shows the top import manufacturers by import records and their countries. Figure 3 shows the top product categories by their manufactures, in desending order of the import records.



Following the trend of origins of the countries, these importers are mainly comprised of companies from China, Mexico and Canada. In particular, in the past September (2022.9), companies from China and Mexico. On the other hand, it should also be noted that, the companies from U.S. are also a major force in terms of supplying products in medical/healthcare industry.
